## Your affiliation with our Pension Fund

Dear Madam or Sir,

We are pleased to welcome you as an employee member of our Pension Fund. Our Management and Advisory Team (Service Gestion et Conseil) is at your disposal to best serve your interests and answer all your questions.

As a new member, we remind you that you are required to transfer all your second pillar assets to our Fund. These assets may be held with your previous pension fund or in a block account with a bank or insurance company. Therefore, we kindly ask you to communicate our bank details to the relevant institutions.

If your assets exceed this limit, you may improve your benefits in the event of early retirement. If this limit is not reached, you have the option of improving your benefits through a voluntary payment.

We also take this opportunity to inform you that in the absence of a survivor's pension, our Fund provides for a death lump sum. As of January 1st, 2026, you will also have the possibility of covering your partner with a survivor's pension.
